Application for Registration of Litter

Notes from Registration Rules:

1. A litter of individual dog, whelped in Jamaica, of which both parents are registered with The Jamaica Kennel Club, shall normally be eligible for registration by the breeder.
2. The Declaration MUST be signed by all owner/s in the case of joint ownership.
 - (a) The breeder of a dog is the person who owns the Dam of that dog when the Dam was whelped.
 - (b) For one signature to be acceptable, written notification of either signature, signed by all parties must be lodged at the office of the Jamaica Kennel Club Ltd. Forms for this are available at the JKC office.
3. A Pedigree Certificate must be provided for EACH pup in a litter that is being registered. Pedigree must be no less than Three (3) generations. Applications will not be processed otherwise.

Notes to Sections C, D & E.

1. NO DOG WILL BE REGISTERED WITHOUT A REGISTERED KENNEL AFFIX (Kennel Name). Application forms are available at the JKC office.
2. No NAME, including the Affix shall exceed 24 letters or characters.
3. Puppies should not be sold less than six (6) weeks old.

SECTION C & D

1. No two dogs with the same name may be registered. Therefore, please give a reasonable selection of names in Section D.

SECTION E

1. The Stud Certificate must be completed. In the case where the Bitch was artificially inseminated, the prescribed form "RECORD BY ARTIFICIAL INSEMINATION" must accompany this application for the registration of progeny.
2. In case of a Bitch IMPORTED in whelp, registration for the litter must be accompanied by a witnessed Stud Certificate, plus a Pedigree of the Sire issued by the KENNEL CLUB of England.
